EFFECTS OF ACUTE EXPOSURE

EYES: May cause eye burns. Symptoms may include pain, tearing, redness, swelling, and eye injury.

SKIN: May cause skin irritation. Symptoms may include redness, rash and mild swelling.

INHALATION: High concentrations of vapor or mist may cause nose, throat and respiratory tract irritation. Symptoms may include coughing and a burning sensation in the nose and throat.

INGESTION: May cause mouth, throat and stomach burns. Symptoms may include nausea, vomiting, diarrhea and severe stomach pain.

EFFECTS OF CHRONIC EXPOSURE: Prolonged contact may cause severe skin irritation. Symptoms may include pain, redness, rash, and swelling.

4. FIRST AID MEASURES

SKIN: Flush thoroughly with plenty of water, then wash with soap and water. Remove saturated clothing. Get medical attention if irritation develops or persists. Thoroughly wash (or discard) clothing and shoes before reuse.

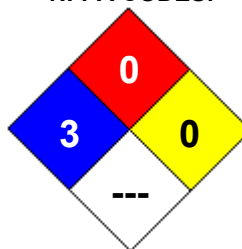
