# **EMERGENCY OVERVIEW**

Opaque, Off-White Liquid . Mint Odor. May Cause Eye Burns and Skin Irritation.

#### **EFFECTS OF ACUTE EXPOSURE**

EYES: May cause eye burns. Symptoms may include pain, tearing, redness, swelling, and eye injury.

SKIN: May cause skin irritation. Symptoms may include redness, rash and mild swelling.

**INHALATION:** High concentrations of vapor or mist may cause nose, throat and respiratory tract irritation. Symptoms may include coughing and a burning sensation in the nose and throat.

**INGESTION:** May cause mouth, throat and stomach burns. Symptoms may include nausea, vomiting, diarrhea and severe stomach pain.

# 4. FIRST AID MEASURES

**EYES:** Immediately flush eyes with plenty of water while holding eyelids apart. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Do not put any medication in the victim's eyes unless instructed by a physician. Get immediate medical attention.

**SKIN:** Flush thoroughly with plenty of water, then wash with soap and water. Remove saturated clothing. Get medical attention if irritation develops or persists. Thoroughly wash (or discard) clothing and shoes before reuse.
